General Conditions

Hybrid Event

DL 2021 will be held as a hybrid event. The participants can choose freely to participate either in-person or online, select and pay the appropriate registration fee. It is possible to modify the participation type by a certain date and given the conditions below.

Vaccination Requirement for In-person Participation

Given the current epidemic situation in Slovakia, it is generally advised for all participants who wish to participate in-person to be fully vaccinated according to the respective regulation of the Slovak government

(<https://korona.gov.sk/en/cestovanie-do-sr/#fully-vaccinated>). The organizers are not able to guarantee participation for persons who do not satisfy this requirement.

Insurance, Release and Waiver of Liability

Neither the Organizers nor SIPKES, s.r.o. are responsible for either the partial or total non-execution of the contract in the event of accident, natural disaster (either threatened or actual), worsening of the epidemic situation or governmental elevation of epidemic countermeasures, in war, threats or acts of terrorism, governmental elevation of the terrorism alert level, strikes, lock down, civil disturbance, or any other cause beyond the parties' control which prevents the Delegate from participating to the conference or which force the Organizers to cancel or reschedule the event.

The Organizers may at their entire discretion repay the delegate fee or Service Charge paid by the Delegate or Exhibitor, or part thereof, but shall be under no obligation to repay the whole or part of such Delegate fee or Service Charge, and shall be under no liability to the Delegate or Exhibitor in respect of any actions, claims, losses (including consequential losses), costs or expenses whatsoever which may be brought against or suffered or incurred by the Delegate or Exhibitor, as the result of the happening of any such event.

Payment Conditions

All payments are to be made in EUR. All prices are shown including VAT. As VAT may increase without notice and any such change will be reflected in final rates.

After finalizing your registration for DL 2021 and/or its satellite workshops, you will receive full confirmation and a receipt for the payment of your registration fee. The confirmation acts as a contract and these terms and conditions will apply.

No discount will be provided in case of early settlements. Payment for multiple registrations can be merged into one payment.

Methods of Payment:

- Credit card: only Eurocard/MasterCard, Visa and American Express are accepted. Please note that the merchant's name that would appear on your credit card statement would be "SIPKES s.r.o.". All costs are borne by the ordering

customer.

In some particular cases, payment by credit card may not be available.

- Bank transfer: All necessary information will be sent after submitting the registration in e-mail and attached Proforma Invoice.

Registration cancellation and modification

After login to the conference web page <http://dl2021-registration.sipkes.sk/user.login/> there is a possibility to modify registration details and to resend the confirmation e-mail with the official receipt attached. In case of registration details modification with a need to refund the payment difference, contact the organizers by e-mail via dl2021-registration@sipkes.sk. No refunds of the payment difference are guaranteed after August 31, 2021 CEST in case of modification of the registration details.

Withdrawal of participation in a written form should be done by e-mail via dl2021-registration@sipkes.sk before August 31, 2021 CEST.

The registration fee or the respective difference will be refunded (with a deduction of 10 % to cover the handling costs). No refund will be granted after this date.

Update Aug 23, 2021: Free Online Registration

Each *in-person* participant is required to register for in-person participation and pay the respective registration fee. For each paper that will be presented *online*, one *unique* online registration and payment of the respective online fee is required.

Free registration will be granted to online participants who *have not co-authored* any paper, and to online participants such that for *all* their co-authored papers one of the following holds: (a) the paper will be presented in-person by one of their paying registered co-authors, or (b) the paper will be presented online and it is covered by one *unique* paid online registration by one of their co-authors.

The free access will be provided upon completion of a separate free online registration form that must be submitted by Sep 15, 2021.
